

## **Privacy Policy**

#### **What entities provide internet and web services to the South Central Nebraska Czech Society?**

The South Central Nebraska Czech Society (SCNCS) engages the following companies for internet and web services.

- Domain.com, the domain name provider
- Wix.com, the web editing and hosting provider.

The above two companies are collectively referred to as “the providers” in this document. “You” refers to any person that views the website. “SCNCS” refers to the South Central Nebraska Czech Society.

#### **What type of information does the website collect?**

The providers may collect and store any information you enter on the SCNCS website or provide SCNCS in any other way. In addition, the providers collect the Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information and purchase history. SCNCS may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page.

SCNCS does not collect personally identifiable information (including name, password, communications); payment details (including credit card information), comments, feedback, product reviews, recommendations, and personal profile.

The SCNCS will collect email addresses for persons who request to be put on the email list.

The SCNCS website does not have a login feature or service and so the SCNCS is not collecting username, user id, or password information.

#### **How does the website collect information?**

The providers collect such non-personal and personal Information for the following purposes:

1. To provide and operate the internet and web hosting services;
2. To create aggregated statistical data and other aggregated and/or inferred non-personal Information, which SCNCS or the service providers may use to provide and improve the respective services;

3. To comply with any applicable laws and regulations.

#### **How does the domain name, website and the web hosting service store, use, share and disclose your site visitors' personal information?**

The SCNCS website is hosted on the Wix.com platform. Wix.com provides SCNCS with the online platform that allows SCNCS to share information with you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

SCNCS does not use direct payment gateways offered by Wix.com. However, all direct payment gateways offered by Wix.com adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.

#### **How does the website communicate with site visitors?**

The SCNCS website does not sell products nor collect credit card, debit card, or bank information. Therefore, it is unlikely that the SCNCS would reach out to the user unless the SCNCS is first contacted by the user. For these communication purposes the SCNCS may contact you via email, telephone, text messages, and postal mail.

#### **How does the website use cookies and other tracking tools?**

The domain name provider (Domain.com) and the web editing and hosting service (Wix.com) for the SCNCS website may track personal information through the use of cookies. See the security, privacy and cookie tools in your internet browser to view which cookies are stored on your computer.

It's important to note that third-party services, such as Google Analytics or other applications offered through the Wix App Market, placing cookies or utilizing other tracking technologies through Wix's services, may have their own policies regarding how they collect and store information. As these are external services, such practices are not covered by the Wix Privacy Policy not the SCNCS Privacy Policy.
